Goeie dag Boknessers / Gooday Boknessors,

Dit is weereens met groot dankbaarheid dat die Boknes Buurtwag Bestuursspan kan terug rapporteer dat ons 'n relatief lae misdaad-incident tydperk die afgelope 2 maande beleef het. Ons waardering gaan weereens aan die Buurtwag se onderskeie Spanne asook HiTec Sekuriteit en die SAPD vir almal se gesamentlike bydraes gelewer tot die skep van 'n veilige Boknes. /

It is once again with great gratitude that the Boknes Neighborhood Watch Management Team can report back that we have experienced a relatively low crime incident period over the past 2 months. Our appreciation goes once again to the Neighborhood Watch's respective Teams as well as HiTec Security and the SAPS for everyone's joint contributions to the creation of a safe Boknes.

Ons sien ook uit na die Junie / Julie skoolvakansie tydperk waartydens ons heelwat vakansiegangers in Boknes verwag. Ons vertrou dat die vakansiegangers soos in die verlede gedurende die tydperk ook hul eie basiese persoonlike sekuriteitsmaatreëls sal opskerp en sodoende sal bygedra tot die voorkoming van misdaad in die omgewing. /

We are also looking forward to the June / July school holiday period during which we expect a lot of holidaymakers in Boknes. We trust that the holidaymakers, as in the past during this period, will also step up to their own basic personal security measures and thus contribute to the prevention of crime in the area.

MISDAAD INCIDENTE / CRIME INCIDENTS

Die volgende insidente is gedurende April en Mei 2022 via die Buurtwag en of HiTec Sekuriteit gerapporteer en ondersoek: /

The following incidents were reported and investigated during April and May 2022 via the Neighborhood Watch and or HiTec Security:

- a. 14 April 2022. Inbraak by 'n huis in Infante straat. / Burglary at a house in Infante Street.
Die eienaar van die huis woon klaarblyklik oorsee. Die bure het die incident gerapporteer. Dit blyk dat slegs 'n herlaaibare flitslig vermis word, terwyl al die ander - normaalweg steelbare items, netso gelaat is. Dit mag wees dat die dief(we) versteur is voordat hulle meer kon steel as wat dit blyk te wees. /
The owner of the house apparently lives overseas. Neighbors reported the incident. It turns out that only a rechargeable flashlight is missing, while all the other - normally stolen items, are left as is. It may be that the thief (s) were disturbed before they could steal more than it appears to be.

- b. 17 April 2022. Inbraak in 'n voertuig wat voor 'n huis geparkeer was in Potgieter straat – Cannonrocks. / Burglary into a vehicle parked in front of a house in Potgieter Street – Cannonrocks.

Die voertuig se agter venster is uitgeslaan. Die inwoners het die lawaai gehoor en na buite gestorm waarop die diewe weg gehardloop het sonder om iets te steel. Nota: Alhoewel hierdie incident buite die Boknes Buurtwag se verantwoordelikhedsgebied val, word dit steeds gerapporteer sodat Boknes inwoners kan kennis neem dat sulke insidente 'n realiteit is en moontlik ook in Boknes kan plaasvind. /

The vehicle's rear window was knocked out. The residents heard the noise and rushed outside whereupon the thieves ran away without stealing anything. Note: Although this incident falls outside the Boknes Neighborhood Watch's area of responsibility, it is still reported so that Boknes residents can take note that such incidents are a reality and may also take place in Boknes.

21 Mei 2022. Diefstal van solar ligte by 'n huis in 7de Laan. / Theft of solar lights at a house in 7th Avenue.

Die incident is deur die inwoner op Face Book gerapporteer. Geen verdere detail is beskikbaar nie. /

The incident was reported by the resident on Face Book. No further details are available.

Ongelukkig het die afgelope 2x CPF (Community Police Forum) vergaderings nie plaasgevind nie, en is daar dus geen ampelike SAPS misdaad statistiek verslag beskikbaar nie. weer sal aanskakel. Ons sal ook teen die einde van Junie die sentrale stelsel op 'n "UPS" koppel om dit teen Eskom se fliktuasies te beskerm.

As was undertaken in our previous Newsletters, we would like to improve the CCTV camera monitoring system. In the last 2 months the system has been stabilized and a faster internet connection has been installed. All the cameras are operational, except one that we will move soon and then switch it on again after the re-installation. We will also connect the central system to a "UPS" by the end of June to protect it against Eskom's fluctuations.

Thanks to all the people who help keep the camera system running:

- Our 18 x faithful monitors;
- Piet van Tonder who keeps the cameras clean;
- Our 4 x camera coordinators who do system maintenance;
- Anton, Gert, Zonia and Hi-Tec who help when there are problems;
- Marianne, Aart, Meagan and Bruce who recently donated equipment for the camera system.

BUURTWAG PATROLLIE EN BYSTAND / NEIGHBOURHOOD PATROL AND STANDBY SERVICES

Die Boknes Buurtwag Patrollie funksie se effektiwiteit spreek vanself deur die lae misdaadsyfer vir die omgewing. Ons glo dat die huidige na-nag (na 24h00) voertuig patrollies ook positief bydra tot die effektiwiteit van die Buurtwag se aksies. Ons wil egter weer 'n versoek herhaal wat ons by verskeie geleenthede voorheen geplaas het. Die versoek is dat huiseienaars hul erfnummers duidelik voor op hul huise of hekke moet aanbring. Die erfnummer help as verwysingspunt ten tye van 'n noodsituasie of incident. Erfnommers wat veral in die aand duidelik vertoon kan selfs help om lewens te red as 'n ambulans bestuurder byvoorbeeld 'n adres moet soek. Ons vra u om asseblief dringend aan die versoek aandag te skenk. /

The effectiveness of the Boknes Neighborhood Watch Patrol function speaks for itself based on the low crime rate for the environment. We believe that the current late-night (after 24h00) vehicle patrols also contribute positively to the effectiveness of the Neighborhood Watch's actions. However, we would like to re-emphasize a previous request made on several occasions. The request is that homeowners should clearly affix their street numbers at the front of their homes or gates. number helps as a reference point in the event of an emergency or incident. Erf numbers that are clearly displayed, especially in the evening, can even help save lives if an ambulance driver, for example, has to look for an address. We ask you to please pay urgent attention to the request.

Dit blyk dat die Ndlambe Munisipaliteit se kontrakteur redelik goed vorder met die herstelwerk aan die straatligte. Ons wil ook vra dat inwoners wat straatligte wat buitewerking is wil rapporteer, dit direk per Whatsapp boodskap aan Piet van Deventer moet deurgee asseblief. Uiteraard gaan die erfnummers ook in hierdie geval belangrik wees. /

It appears that the Ndlambe Municipality's contractor is progressing fairly well with the repairs to the street lights. We would also like to ask residents who want to report street lights that are out of order to please notify Piet van Deventer directly via Whatsapp message. Of course, the erf numbers will also be important in this case.

Ons versoek ook net weer dat indien u enige verdagte of kriminele aktiwiteite sien gebeur, of self 'n slagoffer is, of weet van 'n incident wat met iemand anders in die omgewing gebeur het, dat u dit asseblief onverwyld aan die SAPD, HiTec Sekuriteit en die Boknes Buurtwag se bestuur rapporteer. Dit sal ons instaat stel om te verseker dat die incident behoorlik ondersoek word. /

We also request again that if you see any suspicious or criminal activity happening, or are a victim yourself, or know of an incident that happened to someone else in the area, that you please report it to the SAPS, HiTec Security as well as the Boknes Neighborhood Watch's management. This will help us to ensure that the incident is properly investigated etc.

PLAKKER SITUASIE BY DIE VULLIS AREA / SQUATTER SITUATION AT THE LANDFILL AREA

Ongelukkig moet ek myself herhaal in die verband. Die situasie met die onwettige plakkars en hul strukture by die vullisstortterrein ("Tip") is nog steeds nie opgelos nie. Na verskeie beloftes van aksieplanne deur die Munisipaliteit blyk dit nou dat hulle uiteindelik met 'n regssproses begin het om 'n uitsettingsbevel te verkry. Verder het die Munisipaliteit 'n nuwe hek by die Tip geïnstalleer. Ongelukkig word die hek nog nie gebruik vir toegangsbeheer nie en is die heining rondom vervalle, en daarom is dit dus 'n sinneloze oefening sovér. Ons hou egter ons hoop op die uitreiking van die finale "uitsettingsbevel" om hierdie onaanvaarbare situasie op te los. /

Unfortunately, I have to repeat myself in this regard. The situation with the illegal squatters and their structures at the landfill ("Tip") has still not been resolved. After several promises of action plans by the Municipality, it now appears that they have finally started a legal process to obtain an eviction order. Furthermore, the Municipality has installed a new gate at the Tip. Unfortunately, the gate is not yet used for access control and the fence around it is dilapidated, so it is a pointless exercise so far. However, we keep hoping for the issuing of an "eviction order" to resolve this unacceptable situation.

Die hoof beweegredes vir die beplande affiliasie met AfriForum is dat AfriForum se Buurtwag Afdeling professionele ondersteuning bied in terme van Regsadvies en Regsverteenvoerding asook logistieke steun en opleiding. Daar is reeds meer as 150 Buurtwagte regoor Suid Afrika wat by AfriForum feaffilieer is. Volgens AfriForum se hoofkantoor is daar tans meer as 100 AfriForum lede geregistreer in die Ndlambe Munisipale gebied. /

The main reasons for the planned affiliation with AfriForum are that AfriForum's Neighborhood Watch Division provides professional support in terms of Legal Advice and Legal Representation as well as logistical support and training. There are already more than 150 Neighborhood Watches across South Africa who are affiliated with AfriForum. According to AfriForum's head office, there are currently more than 100 AfriForum members registered in the Ndlambe Municipal area.
